NOTICE OF LEASE

One Park Row West, Providence, Rhode Island Assessor's Plat 4, Lot 261 (with parking rights that may affect Lots 262, and 263)

This Notice of Lease refers to a Lease Agreement that has a Commencement Date of August 1, 2009, entered into by and between CAPITOL COVE, LLC, a Rhode Island limited liability company ("Landlord") and JOHNSON & WALES UNIVERSITY, a Rhode Island non-profit corporation ("Tenant"), said Lease Agreement being hereinafter referred to as the "Lease". - **4. OPTIONS TO RENEW.** Tenant has the option to renew the Lease for an additional term of two (2) years.
- **5. ADDITIONAL LEASE TERMS.** The Lease contains terms, conditions, covenants and restrictions that are not described in this Notice of Lease. The terms of the Lease will, for all purposes, supersede the terms of this Notice of Lease in the event of any conflict of terms between said documents.
